## **CR GAS WAS AWARDED THE SECOND FASTEST GROWING ENERGY COMPANY IN ASIA AND MADE SIGNIFICANT ADVANCEMENT TO 181 IN 2015 PLATTS TOP 250 GLOBAL ENERGY COMPANY RANKINGS**

Hong Kong, October 28, 2015 - China Resources Gas Group Limited ("CR Gas" or the "Company", HKEx Mainboard Stock Code: 1193; together with its subsidiaries, the "Group"), the leading downstream city gas distributor in China, is pleased to announce that the Group was awarded the Second Fastest Growing Energy Company in Asia by Platts, and ranked 181 in Platts Top 250 Global Energy Company Rankings.

Since 2002, Platts has been ranking energy companies' financial performance globally, regionally and by industry sector based on four key metrics: assets, revenues, profits and return on invested capital. With excellent performance of these four indicators position in 2015 rankings significantly advanced from 218 in 2014 to 181 in 2015. The -year compound growth rate of 26.4% made it the Second Fastest Growing Energy Company in Asia, up from Third position in 2014.
